2012 FEE WAIVER APPLICATION

Due to the large volume of requests for fee waivers, the Law School must review requests carefully. Our policy is to assist those who are truly needy and fee waivers are granted to those applicants who otherwise may be prohibited from applying to Penn Law.

You must submit a copy of your most recent tax return or W2 form(s), a copy of a recent pay stub and an itemized list of expenses if you are not currently enrolled in an academic program. If you are presently in school, you must submit a copy of your financial aid award letter (not your financial aid transcript). In addition, you must submit a copy of your parents' most recent tax return if they claimed you as a dependent regardless of whether you are enrolled in school. Without supporting documentation, your application will not be evaluated. Your completed fee waiver application *must* be submitted **by February 15**. Incomplete forms may be returned to you or delay the review process.

Please Note: If you were granted a fee waiver from LSAC, you do not need to fill out this application. If you have been granted an LSAC fee waiver, your application fee will automatically be waived when you transmit your application through LSAC.

Do not submit the application fee if applying for a fee waiver.
