# Comment on the instructor's (Jonathan Klick) stimulation of interest in the subject matter and independent thought.

#### Comments

Professor Klick seems very interested in the law and economics perspective of torts, you can tell he is really engaged by considering the economics view of it.

Prof. Klick is extraordinarily knowledgable about tort law and was able to cultivate an engaging intellectual environment. I particularly appreciated the way in which he emphasized the large–scale and often philosophical implications of the material we were learning without getting too caught up in the details of the cases or the stilted traditions of the doctrine. I feel that I am leaving this class not only with a better understanding of tort law, but also as a more well–rounded thinker.

Clearly interested in the subject matter, more so from an economics perspective than anything else. But this was a breath of fresh air in a way.

Prof. Klick very clearly has a thorough knowledge of torts and especially how it interacts with law and economics perspectives. He was very approachable but definitely preferred to stick to his posted office hours times. However, if students were unable to make it to those meetings he was willing to work around our schedules.

He did a great job. We had very interesting discussions. He also brought in relevant contemporary outside information.

Prof. Klick's comments about issues which were always different from what I used to think largely stimulated my interest.

#### Comment on the strengths and weaknesses of the course. How could it be improved?

#### Comments

It would be helpful if he assigned a text to refer to the law and econ stuff. I also think that the focus of the class should be more on the fundamental of torts, which I feel we glossed over in class.

Strengths are that he invites conversation/discussion each class. Weakness is that usually, he pushes back on anything that anyone raises so it doesn't really seem like there's a reason to speak up in class.

The course is intellectually engaging while also effectively teaching the fundamentals of tort law. Prof. Klick comes from a very specific tradition—Law and Economics—which might not be to everyone's liking (I, for one don't subscribe to the philosophy), but Prof. Klick is very upfront about the fact that he is only presenting one perspective and is always open to hearing others.

Strengths were encouraging people to share and really think through their own viewpoints.

strength was learning torts through a completely new framework. Weaknesses is that I don't think this version of torts will help me a ton on the bar

Course went well.

the course could be improved with a bit more structure. He does not really give assigned readings by dates but rather instructs to read 30–40 pages and then glosses over much of it during class discussion. If there were more structure to this course, it would be greatly improved.

A couple of word problems here and there could be helpful for us to learn to articulate the concepts.

The course was wonderful in that it presented to me and trained me to equip a whole different set of minds/rationales in examining and analyzing torts and real—world experience. But in the first half of the semester, I was honestly quite confused at the elements, relationship, and general structure of causes of actions in tort law. But towards the end, the things just magically held together.

I don't feel like I know torts, but I do think I learned way more about econ than I wanted. Often, the course seemed to almost try to provoke controversy – not about the law, but about particular viewpoints.

# Comment on the online instruction in this course specifically. What aspects worked well? What suggestions would you offer for improvement?

#### Comments

Because of the pandemic and online instruction, I think it would have been helpful to have more support recognizing that students are dealing with an even more difficult first semester of law school. A TA would have been helpful, or even more engagement outside of just class and office hours. Other professors seemed to make some adjustments to their teaching in light of it being virtual, but I don't think Professor Klick did.

I think that online instruction was well–suited to Prof. Klick's teaching style and allowed students to feel more comfortable participating in class.
