# 2023-2024 Academic Year Waseda Law School Information for Exchange Students

### 1. Course Selection

Waseda Law School (WLS) will offer about 10 courses conducted in English in Fall 2023. Most of the courses are semester-long two-credit courses that meet once a week for one semester, spending 100 minutes each time.

Please note that the exchange students must attend 10 or more hours of courses (6 or more courses) per week in Waseda Law School. This is a legal requirement, and if the student fails to register for at least 10 hours of courses per week, the "Student" status of residence will be terminated. Please be sure to attend 10 or more hours of courses.

### 2. Visa

Due to the regulations under the immigration law in Japan, a non-Japanese exchange student is required to enter Japan with a valid "Student" visa. A "Certificate of Eligibility (CoE)" will be forwarded to a student as soon as WLS receive it from Tokyo Immigration Bureau <u>around August</u>. The student is required to submit the CoE to Japanese Embassy or Consulate-General of Japan in your area of your country with a valid your passport to obtain a "Student" visa. Please be sure to obtain a "Student" visa before departure.

### Note:

<u>Please purchase the flight ticket to Japan after obtaining the "Student" visa.</u> In addition, <u>the exchange</u> students must enter Japan with the proper status of residence ("Student" status of residence), because

those who enter Japan with a visa waiver status or a different status of residence have to leave Japan once, and then enter again with a "Student" visa. <u>WLS cannot make any special arrangements for those planning to enter Japan earlier.</u>

Fall semester classes end on February 4 (Sun.), 2024 at Waseda University, however the exchange students enrolled at WLS can finish their study at WLS on December 25 (Mon.), 2023 by fulfilling substitute assignments.
