#### About the program

A unique year-long Master's program has been created in Paris by one of France's most highly regarded universities, the Institut d'Études Politiques de Paris (**Sciences Po**).

The program awards a **Master's Degree in Law** from Sciences Po ("Master Droit économique"). The aim of this highly selective, multi-disciplinary, and international program is to provide in-depth analysis of issues involved in the global market with a European perspective. It is designed to provide a comprehensive theoretical and practical approach to legal issues in a global context, whether from a perspective of international litigation and arbitration, of supranational economic governance, or as a matter of transnational advocacy in human rights cases. The more theoretically inclined will find exciting new areas for research on issues of global law and governance. Taught by experts from Sciences Po, the program involves interactive, bi-lingual discussion in small groups in which American students, will mingle with their European counterparts. Courses are taught in French and in English. Students will have the opportunity to take their courses in one or both languages.

Mention the <b>courses that you will take</b> and explain <b>why you want to study at Sciences Po</b> next year.</p> <ul style="list-style-type: none"> <li>* Proof of proficiency in French</li> </ul> <p>Please note that you have the choice to take all your courses in English or to take some or all your courses in French. <b>Courses</b>	<p>All students will be enrolled in graduate courses that cover intermediate and advanced perspectives in international private and international public law, global governance of climate change, and global legal humanities. Elective course topics include, among others: international business transactions and contracts, the World Trade Organization, International finance, International arbitration, intellectual property, General International Public Law, Theory of international law making, Global competition law, Global conflict of laws and cross-border litigation, etc. Students will also enroll in two workshops, building specific legal methods, and one research seminar, enriching perspectives in theoretical research topics in legal fields.</p> <p>More information available <a href="#">here</a>.</p> <p>*For students wishing to complete an intensive curriculum dedicated to transnational arbitration, please consult <a href="#">the TADS LLM curriculum</a>, which may also be considered, if taken fully.</p>
