Strengths: Professor Klick was incredibly knowledgeable. The puzzles were very interesting. I enjoyed the focus on economics over legal analysis. Weaknesses: too much assigned reading. not enough clarity on what we should be taking away from the readings, especially in regards to the exam
Sometimes I can't tell when Klick is dismissing a viewpoint because he disagrees with it or dismissing it because the field of econ has disagreed with it. For example, when he calls it "hipster anti-trust" – does he mean that the ideas are bad or that he personally disagrees?
Reading is a lot (not many people did it). The puzzles were good and kept things interesting, and the material is interesting.
The shortened schedule over the summer make it difficult to really get into the course material but Professor Klick did a good job of highlighting important info that was necessary to learn the topic
